

Minutes of The Bay Park Conservancy Executive Committee Meeting

Monday, March 18, 2024 8-9am via Zoom

Ms. Compton called the meeting to order at 8:01 AM.

Mr. Lafley provided an overview of February and 2024 Calendar Year results progress versus annual goals.

- February was an all-time record month since the park Grand Opening in October, 2022. Nearly 40,000 guests came to The Bay in February.
- Park Guest visits and satisfaction, fundraising, and Phase 2 design/planning are on track and on budget through February.
- The Bay is delivering on "one park for all" with a broad and diverse mix of park guests.

A Gulf Coast Community Foundation \$2 million Community Challenge Match in 2024 was approved by the Gulf Coast board on February 20 and announced to the public at The Nest at The Bay on February 28.

• This generous challenge match should enable The Bay to deliver \$4.5 million in private donations in 2024 and, in addition, earn the \$1 million match from The Patterson Foundation for achieving the fourth \$5 million private fundraising milestone, which would complete the second major TPF challenge campaign.

- Kebony wood will be replaced where it's not performing as expected -- on the Bayou Bridge, and on the Mangrove Bayou Walkway, and other areas, as needed, throughout the park.
- Maintenance, operating, and safety improvements will be made at the Playground and The Oval.

BPC Organization Update: Since the beginning of 2024, BPC has added four players to the team: Sydney Baulier (Digital Communications Manager), Trey Hammett (Director of Advancement), Michelle Reynolds (Accounting/ Bookkeeping), and Kathy VanDorne (Rentals/ Reception).

- Visit in person, the Pop-Up Giving Station at The Nest and other events taking place in the park (Pop-Up Station Schedule: April 9 12-2pm and 6-7pm, events scheduled throughout the 24 hours).
- Much appreciation and many thanks to the Directors participating in the above.

Mr. Lafley left the meeting at 8:45am.

In Executive session, the Executive Committee and attending Directors discussed governance improvements to support board and management continuity, 360-reviews of Executive Committee members and Directors, an Advisory Council or Ambassador program for outgoing Board members, and potential plans for Management succession in 2025.
